Petrie is the author and illustrator of the book *Drawing Landscapes in Pencil*, *The Color Book*, *The Watercolorist's Guide to Painting Trees*, and *The Big Book of Painting Nature in Watercolor*.



Irv Docktor, another classic artist, whose work is colorful and dynamic, is a 20 year member of NJWCS, as well as award winner with the American Artist Professional League, Hudson Valley Art Association, Philadelphia Watercolor Society (Best in Show), North East Watercolor Society and the Salmagundi Club. 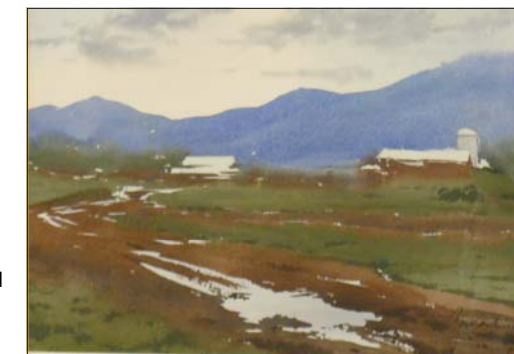

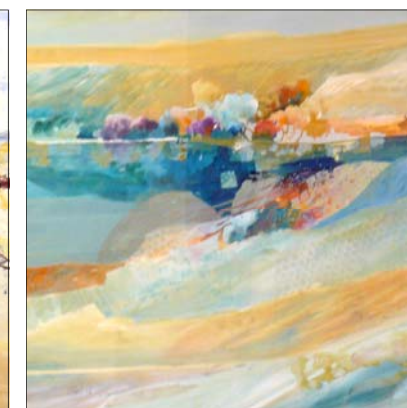
I do miss all my friends in the NJWCS and wish you all continuing success.
