Entries will be accepted **only** through the online entry process from April 1 through June 1, 2019.

Entry fee: \$10 for Associate Members of NJWCS (with 2019 dues paid by April 1, 2019)

All Entries accepted. * - You may submit one image only

Eligible Works: The exhibition is open to **New Jersey residents only** and New Jersey Water Color Society Associate Members with 2019 dues paid by April 1, 2019. We accept paintings done in water media (including acrylic) and collage (collage must be made with handmade water media on paper by the artist). All works must be painted on paper/yupo/watercolor boards. We do not accept paintings previously shown in any NJWCS exhibition or show, copies, prints, classwork or workshop creations, computer generated, water-soluble oils, or varnished, woven or dimensional build-up of textural materials or nude paintings.

Digital entries only: Click <http://www.njwcs.org/AssociateShow.htm> and follow the instructions. We recommend you prepare your image first and then proceed to the entry form. JPEGs should be of the image only, no mats, frames or extraneous backgrounds. Correctly orient the image, horizontal or vertical. All entries must be in JPEG format, RGB, 1200 pixels on the longest dimension, 300dpi and file size not to exceed 3 MB. Name your JPEG file:

Last Name_First Name_Title. For example: Doe_Jane_Summer Scene.JPG

Enter one image, only. Please include a sale price or mark NFS if not for sale.
